- 1. The CAS has clearly no jurisdiction to entertain the appeal filed by the IBSF in the case CAS 2017/A/5476 The International Bobsleigh and Skeleton Federation v. Alexander Tretiakov, Elena Nikitina, Mariia Orlova, Olga Potylitsyna, Ilvir Khuzin, Alexander Kasyanov & Aleksei Pushkarev).
- 2. Pursuant to Article R37 of the Code of Sports-related Arbitration, the procedure CAS 2017/A/5476 The International Bobsleigh and Skeleton Federation v. Alexander Tretiakov, Elena Nikitina, Mariia Orlova, Olga Potylitsyna, Ilvir Khuzin, Alexander Kasyanov & Aleksei Pushkarev) is terminated and removed from the CAS roll.
- 3. The present Order is rendered without costs save for the Court Office fee of CHF 1,000 already paid by International Bobsleigh and Skeleton Federation and which is retained by the CAS.
