PARTICIPATION ELIGIBILITY

The competition will be carried out in accordance with 2019 IBSF International Women's Monobob rules.

All athletes must have a valid IBSF E-license issued by their National Federation.

It is the responsibility of the National Federation to enter athletes for event through the IBSF online system <http://ibsf.sportresult.com>. The deadline for submission is five days before the first Team Captain's meeting.

STATEMENT OF LIABILITY

All athletes, officials and other members who attend and participate in the event do so at their own risk. The organizer shall not be responsible for any loss or injuries incurred or suffered by any athlete or official in conjunction with the organization or staging of the event.

All athletes are required to be covered by insurance against accidents deriving from the practice of bobsleigh, including civil damages to third parties, for transport by ambulance, medical treatment and hospital treatment.

All entry fees must be paid in advance to the IBSF with payment confirmation shown to the IBSF coordinator before the 1st TCM

Monobobs and runners will be provided by IBSF. The transport of the monobobs will be provided by the IBSF. IBSF will provide technical support (mechanics and helpers) to help the national federations with monobob maintenance. All equipment required for maintaining the sled and runners will be provided by IBSF.

ADDITIONAL INFORMATION

Athletes are responsible for transport to event, including transfers from arrival location (airport/train) to hotel and back to departure location.
