## **Declaration of National Federation - IBSF E-LICENSE AND REGISTRATION SYSTEM**

1. By submitting these information and being fully aware of the civil and penal responsibilities involved, the signing national federation (National Federation) responsible certifies that all personal information featured on the IBSF E-LICENSE AND REGISTRATION SYSTEM is true and also certifies that it is fully aware of all the IBSF regulations and is committed to comply with them and has instructed its athlete and team members in details about it.
2. By applying for the License (athletes only) and being fully aware of the civil and penal responsibilities involved, the National Federation to which the athlete (License Holder) belongs, certifies that the latter:
  - a. is a member of his Federation, is suitable for practicing bobsleigh/skeleton racing,
  - b. is covered by insurance against accidents deriving from the practice of bobsleigh/skeleton racing, including civil damages to third parties, for transport by ambulance, medical treatment and hospital treatment,
  - c. has undergone a medical certification to attest to his suitability to practice bobsleigh/skeleton racing, as certified by a physician.
3. The License (athletes only) has a validity of one year (October 1 to September 30).
4. BY applying for the License (athletes only) respectively season-registration (team members), the National Federations accepts and agrees (i) to the IBSF Statutes, the IBSF International Rules, the IBSF Code of Ethic, all relevant IBSF Code of Conducts and all other IBSF regulations (see all documents under <https://www.ibsf.org/en/inside-ibsf/downloads>), (ii) to IBSF role as original organizer and rights holder of all IBSF Events and (ii) that IBSF is entitled to exploit all relevant (commercial) rights to the IBSF Events (such as but not limited to media rights, marketing rights and data related rights).
5. The National Federation holds an agreement with the athlete / team member in which the athlete / team member acknowledges and agrees:
  - a. to the Terms and Conditions for Use of the IBSF E-LICENSE AND REGISTRATION SYSTEM
  - b. to the IBSF Statutes, the IBSF International Rules, the IBSF Code of Ethic, all relevant IBSF Code of Conducts and all other IBSF regulations (<https://www.ibsf.org/en/inside-ibsf/downloads>)
  - c. to IBSF role as original organizer and rights holder of all IBSF Events
  - d. that IBSF is entitled to exploit all relevant (commercial) rights to the IBSF Events (such as but not limited to media rights, marketing rights and data related rights).
  - e. IBSF is exclusively entitled to make sound and/or image recordings (including Live Feeds) of and at the IBSF Event or of parts of the IBSF Event(s), or to have these made by a third-party host broadcaster or any other third party/parties.
  - f. IBSF and any official data partner is exclusively entitled collect, collate, use, distribute and exploit sports related data at the IBSF Event that may include sport related data of the athlete / team member.

- g. to be filmed, videotaped and photographed, and to have his name, image, picture, likeness, voice and biographical information otherwise recorded, in any media through any technology, by the IBSF's official photographer(s), film crew(s) and video crew(s), and by any other entity authorized by the IBSF.
- h. grants to IBSF the irrevocable, perpetual, fully paid-up, worldwide right and license to use, and to authorize third parties to use, distribute and exploit in all media and through all technologies, the content collected and produced as per e., f. and g. subject to the following restrictions ("Produced Content"):

(1) in no event may the IBSF use or authorize the commercial use of the Produced Content in any manner that would imply athlete / team member's endorsement of any company, product, or service, without athlete/team official's express written permission.

(2) private information collected for the sole purpose of Anti-Doping will only be used for Anti-Doping Preventions purposes and IBSF will adhere to the International Standard for Protection of Privacy and Personal Information (ISPPPI) as set by WADA.
